Please review the following rules and regulations governing FLORIDA SUPERCON, and if you have any questions or concerns, please contact us. By signing and returning the resulting contract, you confirm that you have read the following, agree to, and will comply with, all rules and regulations as stated below.

Each Independent Publisher, Crafts Person and Filmmaker space is approx. 8 foot wide by 6 foot deep and come with with (1) eight foot long table, 2 chairs and 2 Badges. These tables are placed directly next to each other in a row. These spaces are reserved for independent comic book publishers who wish to be located in the Main Exhibition Room, Crafts Person's that wish to have a table space and

not a booth and Filmmakers wishing to promote/sell their own independent films. Persons setting up in these spaces may not sell any item not created by themselves or their company.

- (1) All exhibitors and vendors must submit a signed copy of this contract. It can be emailed to mike@floridasupercon.com or mailed to us at Super Conventions (9091 Lime Bay Blvd. #112, Tamarac FL. 33321). No vendor will be allowed to set up without submitting a signed contract.
- (2) Space and Table Rental: Each space is (1) 8 foot table. Each space comes with (1) 8' foot table, (2) chairs, (1) wastebasket and (2) badges. There is approx. 4 feet of space behind each table. Check in at Artist Registration to receive badges and table assignment. You may purchase additional badges for \$50. These badges are for exhibitors only and are not to be resold. Reselling exhibitor badges is a violation of the terms of this agreement.
- (3) All booths must be manned at all times. Florida Supercon will not be held responsible for any issues arising from an unmanned booth during show hours.
- (4) Booths must remain intact throughout the hours of the convention and may not be dismantled prior to the closing of the convention. FSC is a 4 day event. Vendors and Exhibitors may break down on Sunday night at the close of the vendor room, or on Sunday at the close of the vendor room. The loading dock will not be open for breakdown prior to the close of the exhibition room. If you break down your space prior to the end of the show you will be banned from setting up at future shows. Attendee's have paid for the ability to shop with Vendors and Exhibitors and expect them to be set up during show hours. By breaking down early you are doing both the attendees and the show a disservice. Please be advised that there are vendors and artists that we will no longer welcome back due to breaking this rule. The shows management takes this very seriously. It is unfair to attendees, the show and other vendors to break down early. If you cannot stay until the end of the show, please do not set up. Seriously.**
- (5) Assignment of space will be by show management. We will try to accommodate as many special requests as possible but cannot guarantee space.
- (6) Exhibitors will comply with all local, state and federal laws, and will not hold management liable for any breaches, losses, or damage to themselves or their property. All vendors and exhibitors agree to hold blameless Florida Supercon and all Florida Supercon staff members and workers against any loss, damage, theft, expenses, claims or actions arising from any personal or property damage, loss or theft due to said vendors/exhibitors participation in Florida Supercon.
- (7) In addition, all vendors/exhibitors/artists acknowledge that Florida Supercon and all Florida Supercon staff members, workers, employees and agents, will NOT provide or maintain insurance coverage for vendors/exhibitors persons or property, and it is their sole responsibility

to obtain insurance covering loss.

- (8) Florida Supercon in no way endorses any artists/vendors/exhibitor's merchandise, exhibits, views, beliefs, or actions. All artists/vendors/exhibitors are deemed to be their own business/entity and in no way reflect the views, beliefs, intentions and/or direction of Florida Supercon. Artists/vendors/exhibitors do not represent Florida Supercon in any way.
- (9) All merchandise bought or sold at the Florida Supercon is done strictly between artists/vendors/exhibitors and attendees/buyers, Florida Supercon is not party to or responsible in any way for any transactions made between said parties.
- (10) All adult materials must be either behind the table or, if displayed on a table or display rack bagged or covered so that minors may not open it. Any adult material containing nudity must be covered in accordance with local and state laws. Artists/Exhibitors agree not to sell any adult materials to minors. Violating this rule is cause for immediate dismissal from the show with no refund, and being banned from any future events hosted by the shows management.
- (11) State tax is the responsibility of the artist/vendor to collect according to state laws.
- (12) Exhibitors who renew for the following year on Sunday of the event each year will be "grandfathered in" and pay today's price. Not Transferable.
- (13) Exhibitors will be supplied with two badges. Additional badges may be purchased in advance for \$50. Badges may not be sold, loaned, or otherwise transferred. Exhibitor badges do not allow access to special functions that require a separate admission price (i.e. celebrity dinners, tournaments). Florida Supercon requires that all exhibitors not only wear an exhibitor badge, but a general admission bracelet as well. This is done to prevent fraud as well as limit the amount of people gaining admittance to the show off of one badge. This may be inconvenient, but we do this to ensure that we will be able to host future events. We depend on admission monies to pay for the show. Without this money, we're out of business, and you have one less viable show to sell your merchandise.
- (14) Electrical service for your booth is available for \$60 from Florida Supercon in advance. At the show, Electrical services will be available from the convention center and may be a higher rate.
- (15) No exhibit may block or interfere with other exhibits or with the aisle space. Any damage caused to the building or its furnishings by the Artist/Exhibitor are the sole responsibility of the Artist/Exhibitor.
- (16) Should you (the exhibitor) find that you are not able to attend Florida Supercon and have already paid for your table, the policy is as follows: 50% refund if cancelled prior to March 1, 2012. ****NOTE** ANY CANCELLATION AFTER MARCH 1, 2011 WILL RESULT IN THE FORFEITURE**
